## **New Business & Considering Motions:**

#### 1. Schedule

- a. Les motions a change to our 2020 season. This change would include 8 weekends, spread out over a 4 month period starting May and ending August. Ideally this would look like 2 weekends per month. #### 3. 50 Class

a. Format is currently by age 4-6 years and 7-8 years. Les motions we switch to Advanced 4-8 years and Beginner 4-8 years. Justin 2nds this motion. All in favor.

#### 4. Board Gate Fees

a. Les motions that all board members are exempted from gate and camping fees as a perk for their dedication to the AMSA organization. Justin seconds. Majority vote yes.

### 5. Abuse & Bullying

- a. D'ette brings forward to the board that the issue of abuse & bullying needs to be addressed directly. There is abuse and bullying occurring on and off of the track, not just involving riders but also their families and supporters.
- b. AMSA has zero tolerance for this behavior and going forward any situations of abuse and/or bullying will be dealt with immediately and directly by the board members. This negative behavior will result in the disqualification of that rider related to the incident.
- c. Les states that we need to have a focus on positivity.
- d. Sara states that this should be mentioned at every riders meeting to engrain in our community that it will not be tolerated.

### 6. Fundraising Campaign

a. Les states that we need to get on this right away in preparation for the 2020 season. We need to extend this campaign to our members to get their help in securing donations to help our organization run.
